## **2009 Match Update**

### **2009 Match Dates for 2010 Appointment Year**

*National Resident Matching Program (NRMP)*

*Thoracic Surgery Match Schedule*

Match registration opened: January 7, 2009

Rank order list system opened: April 8, 2009

Quota change deadline: May 13, 2009

Rank order list closes: May 27, 2009

Match Day: 12:00 p.m. ET, June 10, 2009

The 2010 appointment year rank order list system is currently open through May 27. It is especially important that all program directors act with the utmost integrity during this phase of the Match. The NRMP maintains the highest professional standards in the conduct of the Match and in its interactions with all Match participants: applicants, program directors, institutional officials, and student affairs deans. The NRMP expects all Match participants to conduct their affairs related to the Match in an ethical and professionally responsible manner. All Match participants are urged to read the NRMP [Statement on Professionalism](#).

A few reminders:

- Applicants and program directors may express their interest in each other; however, they must not make statements implying a commitment.
- It is a breach of the applicable Match Participation Agreement for either party to suggest or inform the other

that placement on a rank order list is contingent upon submission of a verbal or written statement indicating ranking intentions.

- Program directors and applicants frequently engage in the practice of sending letters following the applicant's interview with the program. Those letters often contain statements that can be misinterpreted by either party. Match participants must understand that such letters are not binding and have no standing when final rank order lists are submitted.

### **2009 In-Training Exam Update**

The 2009 In-Training Exam was held April 4, with a back up exam held April 11. A total of 267 residents and fellows sat for the exam, 12 less than the number of exam candidates in 2008. Sixty-nine U.S. programs and eight Canadian programs were represented on exam day.

Program directors can review their residents' exams at <http://www.ctsnet.org/examdirector/tsda/16>. Comparative performance reports will be mailed in late May or early June. Percentile ranks will relate the performance of residents to that of other residents according to year of residency. Performance reports are confidential and are to be distributed and reviewed one-on-one with each exam candidate. It is expected that the program director will meet with individual residents to go over exam results, provide feedback, and identify areas in need of remediation. TSDA does not send score reports to individual residents.

The TSDA In-Training Exam Committee is already planning for next year's exam, tentatively scheduled for April 2010.

### **Program Directors Workshop a Success**

The TSDA hosted an accreditation review workshop on January 24, 2009 in San Francisco for more than 90 program directors, associate program directors, faculty, and coordinators. Attendees were mailed a Certificate of Attendance in early March.

The workshop, facilitated by Walter Merrill, MD and a faculty of experts, covered a variety of important accreditation topics, including educational and administrative expectations for thoracic surgery residency programs, an overview of the accreditation process, and first-hand account of a site visit, among other topics. Workshop faculty included William Baumgartner, MD, ABTS Executive Director; John Brown, MD, TSDA President; John Calhoon, MD, TSDA President-Elect; Irving Kron, MD, ACGME/RRC Thoracic Surgery Committee; Seenu Reddy, MD, University of Texas-San Antonio; Doris Stoll, PhD, GME consultant and former thoracic surgery RRC Executive Director; and Curt Tribble, MD, TSDA Curriculum Committee.

The four-hour workshop was well received by attendees. The workshop overall earned a 4.5 rating on a 5-point scale, and many found the level of detail about the accreditation process and site visits very helpful. Comments included:

“Important to know from experts how to best prepare for review and about the workings of the RRC and ABTS.”
